- I grant permission for the Madison Art Club (MAC) and Art On Main gallery (AOM) to use images of my artwork for the sole purpose of advertising and promoting the exhibit. I retain sole copyright of my artwork.
- I agree not to remove my artwork from the Show prior to December 31, 2017.
- I agree to pick up my (unsold) artwork between January 2-6, 2018 unless alternate arrangements are agreed upon by the MAC/AOM.
- I hold harmless the MAC/AOM for artwork I have not picked up by January 7, 2018.
- I understand that the MAC/AOM does not carry insurance on artwork exhibited, stored or offered for sale in the Art On Main Gallery & Gift Shop. Artists are strongly encouraged to insure their work. The MAC/AOM will not be held responsible for loss or damage of artwork, though every effort will be made to handle and exhibit the work appropriately.
- I understand that the final decision as to the suitability of all artwork for the Square Deal Show rests with the Madison Art Club.
- I understand that my Entry Fee is not refundable, even if I do not deliver the finished canvas(es) for the Square Deal Show.
- I grant permission for the Madison Art Club to deduct commissions from the \$99 sales price of my artwork in the amount of 25%. The MAC will remit the balance of **\$74.25** per canvas to the address on this form by the 15th of the month following the sale date.
- The MAC will collect 7% sales tax & remit to the Indiana Department of Revenue.
- By signing this document, I agree that the Madison Art Club (MAC) and Art On Main (AOM) bear no responsibility for the artwork I provided for the Square Deal Show. I assign, hereby fully, finally, and irrevocably release and agree to hold harmless the MAC/AOM and its officers, agents, volunteers, staff and assigns, for any and all losses, damages, claims, suits, causes, happenings,
